



DAILY HOME HEALTH SCREENING

1

SYMPTOM CHECK: Check in with your child each morning for signs of illness. If your child has any of the symptoms outlined here, they should stay home from school.

2

Notify the school if your child is absent for signs of illness.

3

CLOSE CONTACT CHECK: Unvaccinated students are required to stay home from school if they have been in close contact with someone in the community or household who has tested positive for COVID-19. Please request quarantine information from your student's school.

What is a close contact?

Being within 6 feet for a cumulative total of 15 minutes over a 24 hour period with someone who has tested positive for COVID-19.

SYMPTOM CHECK

Symptoms commonly found with COVID-19 and other viral infections:

- Sore throat
- Congestion
- Runny nose
- Nausea/Vomiting/Diarrhea
- Headache
- Fatigue/Muscle Aches
- Body Aches/Chills

Symptoms frequently associated with COVID-19:

- Fever (100.4 or higher)
- Cough
- Vomiting/Diarrhea



WHAT HAPPENS IF MY STUDENT BECOMES A CLOSE CONTACT?

- 1** School is notified that a student tested positive for COVID-19.
- 2** District Nurse and school staff identify the close contacts of student who tested positive. (Definition of close contact: within 6 feet for 15 minutes or longer.)
- 3** District Nurse and school staff notify close contacts via phone call and follow up with email instructions.

Community/Household Exposure: Unvaccinated Close Contact

- Student quarantines at home for 10 days.
- Student may shorten their quarantine if they test on or after day 5 of exposure with a laboratory confirmed test (PCR or Rapid Antigen Test, no home test.) Student may return on day 8, if the test is negative.

School Exposure: Unvaccinated Close Contact

Unmasked

- Student quarantines at home for 10 days.
- Student may shorten their quarantine if they test on or after day 5 of exposure with a laboratory confirmed test (PCR or Rapid Antigen test, no home test). Student may return on day 8 if the test is negative.

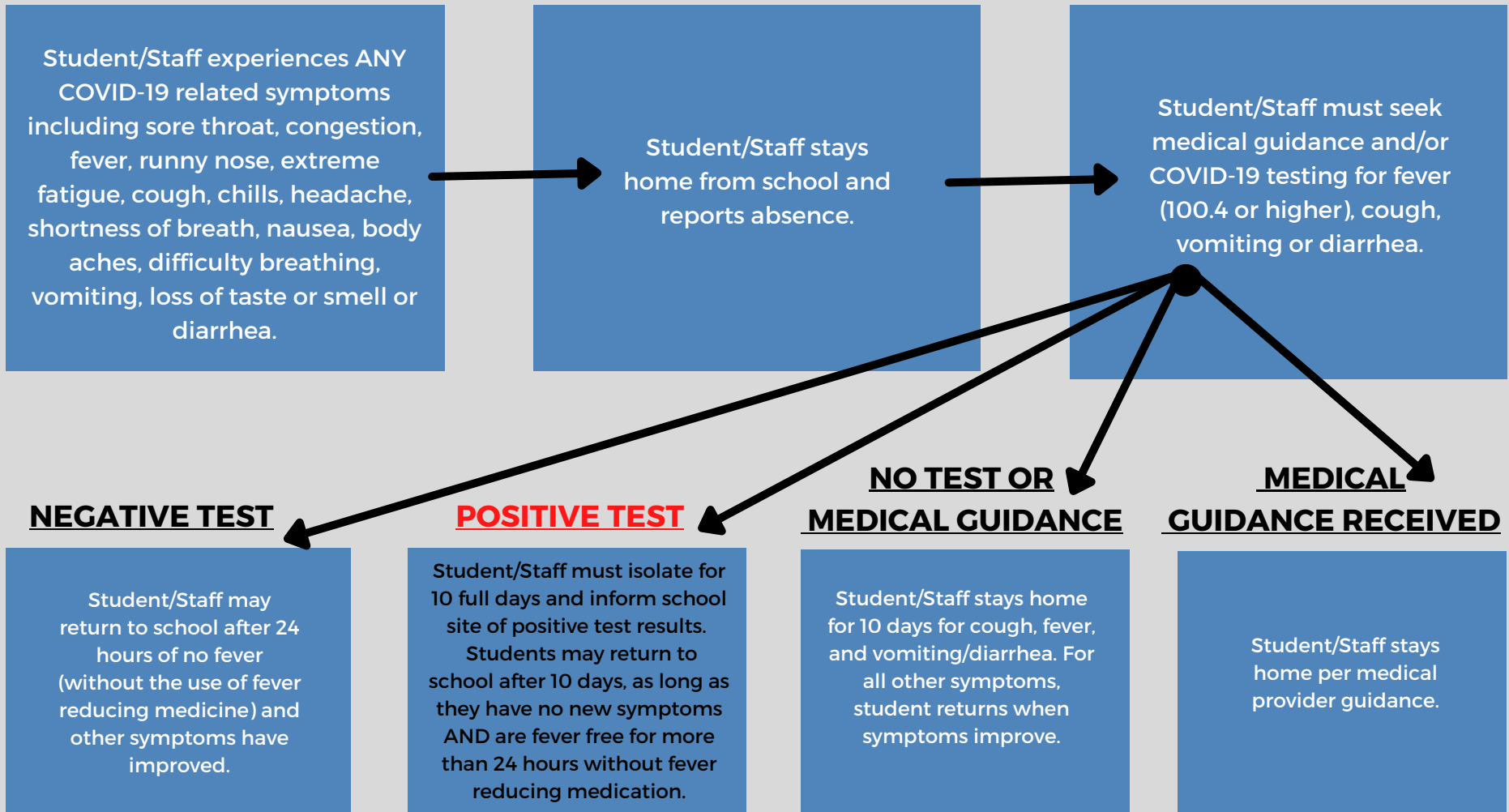
Masked

- Modified quarantine (school setting only): If both parties were wearing masks during exposure period, close contacts can continue to attend school only. Athletics and extra-curricular activities in school or community are not allowed during the quarantine period.
- Students must be tested twice and can be released from quarantine on day 8 after exposure if the second test is conducted on day 5 or later, is negative and student is asymptomatic.

School/Community/Household Exposure: Vaccinated Close Contacts

- No quarantine required for students who are vaccinated as long as you have no symptoms. (You are considered fully vaccinated 2 weeks after you receive the single dose of Johnson & Johnson or the second dose of the Pfizer or Moderna vaccine.)
- Proof of vaccine must be provided to the school for verification.
